NGO Guidelines for Report

A. United Nations, A World Organization

- 1. Your impressions of the United Nations as a world organization.
- 2. The views about the United Nations that are prevalent in your respective major area.
- 3. The political, social, economic, cultural and religious agendas of the United Nations.
- 4. The correlation between the agendas of the United Nations and our mission (YAS C 4) and our ministry (YAS C 22 & 25)

B. NGO Status

- 1. The definition and types of NGO status.
- 2. The obligations of NGO status.
- 3. Your impressions of the positive and negative aspects of NGO status.
- 4. The scope of influence that NGOs can have on the agendas, policies and activities of the United Nations.
- The possibilities for religious influence (such as spiritual presence, ecumenical collaboration, pursuit of Christian values especially justice and peace) at the United Nations.

C. NGO Organizations

- 1. A listing of NGO organizations in your respective major area noting their type of association with the United Nations. Which of them are religious organizations?
- 2. The reasons why organizations decided to become NGOs.
- 3. The means by which NGOs receive information and give it to the United Nations.

D. Steps to Becoming an NGO

- 1. The ways by which NGOs educated their members regarding NGO status and presently involve them in NGO activities. What percentage of the members are active in this? More than or less than 50%?
- 2. The means by which NGOs are represented at the United Nations, such as designated person, office with staff at the United Nations, proxy. It would be helpful to receive protocols and/or job descriptions from organizations for this representation.

E. Suggestions for the Proposal

- 1. The most important reason that you could give for making this proposal.
- 2. A few beliefs, ideas, hopes, etc. that could be included in the proposal

F. Questions for Reflection

We invite you to reflect on this question and to share you responses with us.

How could NGO status at the United Nations enable us,

- 1. To live out our charism to the poor, women and children?
- 2. To strengthen our global responsibility?
- 3. To expand our world vision?
- 4. TO MAKE THE CONCERNS OF THE POOR OUR OWN and TO RISK IN FAITH FOR A MORE JUST AND TRULY HUMAN WORLD?

G. Bibliography/Audio-Visual Materials

- 1. A brief list of books, periodicals, articles, etc., available in your respective major area, they may enable general chapter delegations to learn about the work of the United Nations.
- 2. One or two audio-visual aids, available in the language(s) of your major area, that may be worthwhile to have at the general chapter.
